Affidavit of Iain Clifford Stamp

I, a man by the name of Iain Clifford, a member of Stamp family, living on the land, c/o 61 Victoria Road, SURBITON, Surrey [KT6 4JX] hereby state upon oath in this private court of record:

1. Facts stated herein this Affidavit – **ICS.OPENDEM.AF.01** – are from within my own knowledge or are from information provided to me by my postal agents, save as otherwise stated.

BACKGROUND

1. On 24 August 2022 Dimitris contacted me offering a right of reply relating to multiple allegations of the most serious nature (the “**Allegations**”) in the format of statements (as opposed to questions) regarding MATRIXFREEDOM (**MF**) business and myself.
2. On 12 September 2022 I provided my reply that sufficiently rebutted the Allegations. Further, I engaged in one-to-one meeting with Dimitris further outlining my reply.
3. No further contact was made.
4. On 13 February 2023, despite sufficiently rebutting the Allegations and without further challenge or proper right of reply the Respondent published an article headlined “*Revealed: Facebook still allowing ‘unauthorised’ wealth scheme adverts*” (the “**Article**”). The Article was a hatchet job on myself and MF. The Article makes numerous inaccurate and libellous allegations.
5. Justifiably outraged by the Respondents’ hatchet job and failure to offer me proper right of reply, I offered the Respondents opportunity to cure and desist the Article by way of attending a video meeting with me on Wednesday 02 March 2023 at 14:00, subject to questions received by Friday 24 February 2023 at 17:00 to debate the Article allegations.
6. The Respondents failed to respond to my offer.
7. The Article allegations, published here¹:

- a. MF advertises 'unauthorised' wealth scheme.
 - b. MF targets vulnerable people.
 - c. MF operates an 'infinite income' scheme.
 - d. MF divisions (Sovereign Reserve + Mortgage Free) offered a/the 'infinite income' scheme.
 - e. MF clients, whether defined as vulnerable or otherwise have lost money to a/the MF 'infinite income' scheme.
 - f. MF functions as a 'standard sovereign citizen scam'
 - g. Misrepresents, by way of omission, the contractual relationship with Angelica Musso.
8. Unless you provide with proper right of reply and prove every allegation to be true with irrefutable evidence by 17:00 on 03 March 2023 you accept and agree that your allegations are harassment by publication and libellous.
9. You accept and agree that your harassment and libel has caused me damage and loss of £100,000,000.

NEGATIVE AVERMENT

10. I have seen no verified evidence that the facts as stated herein this Affidavit – **ICS.OPENDEM.AF.01** are not as they are stated to be or as stated to appear to me to be, and it appears that no such evidence exists.



NOTICE TO RESPOND

The above Affidavit – **ICS.OPENDEM.AF.01** (the “**Affidavit**”) is private and confidential and for the attention of the Respondents and Witnesses only.

RESPONDENTS - SUFFICIENT ANSWER

A sufficient answer to the Affidavit shall consist of an affidavit made by the Respondents attesting that the facts as stated in the above Affidavit are not true on a point-by-point basis and underwritten by the equivalent weight of oath as that of the Declarants (a “**Sufficient Answer**”).

The Declarants hereby grant the Respondents fourteen (14) calendar days from the date of delivery of the above Affidavit, as recorded by mail service, in which to make a Sufficient Answer.

If the Respondents fail to provide a Sufficient Answer to the Declarants then they shall by tacit acquiescence convey to the Declarants their agreement that the facts, as they are stated to be or as stated to appear to the Declarants to be, in the Affidavit are true.

Further, the Respondents shall agree by failure to provide a Sufficient Answer that they are estopped from rebutting or disputing the Affidavit at a later time.
